



Paper 2 consists of 200 questions focusing on General Intelligence, Reasoning, and Mental Ability. Each question holds a value of 1 mark, and an incorrect answer incurs a deduction of 0.33 marks.

Paper 3

Paper 3 comprises descriptive questions covering Essay, Precis, and Letter/Application Writing. Moreover, the total marks allotted for this paper are 150. Additionally, there is no penalty for incorrect answers in this paper.

Interview

The interview holds a weight of 100 marks specifically for the position of Section Officer (Gen/F&A/S&P).

Computer Proficiency Test

The Computer Proficiency Test accounts for 100 marks exclusively for the positions of Assistant Section Officer (Gen/F&A/S&P).

CSIR CASE 2023 Exam Dates

The CSIR CASE Notification 2023 was unveiled on December 8, 2023, with the online application form going live on the same day after 5 pm. The deadline for submitting the online application form is January 12, 2024, at 5 pm, while candidates can complete the application fee payment until January 14, 2024, at the same time.
